And that, to me, is what's so important and what I've learned is I think those those three words that were reinforced at the end there, which was I think whatever we do going forward, we need to explain, we need to engage, we need to communicate, we need to feedback and we need to keep telling people why we're doing it because we need to take people on the journey and it's not always going to be easy.

And people can have different views and different opinions, and that's right with something as important as this.

But if we keep explaining, engaging and communicating, I don't think we'll go far wrong.

My final point though I suppose, is that I really like the idea of that.

Uh, that centre for transport excellence. I'm delighted to hear that Essex County Council officers said that they'd supported by the sounds, at least suggested it. So I'm very happy.

I think Jim for us to continue those conversations going forwards into the long term.

Yes.

Can I add my thanks also to the organisers but I have an ask coming up. Today has been an incredibly successful day I think and I asked delegates in some of the breakout sessions what was the best thing, what was the ultimate session, what was the most insightful kind of thing brought forward and you know each and every single person said something different and I think that speaks to the incredible range of the day and the number of sort of voices with expertise and with experience and what they what they have brought. Two standouts for me was in in the this morning the miracle cure of exercise or walking and Scarlett's quite haunting words. "We can't afford what's coming".

That's really stuck with me and a really powerful image was when Joel talked about one double Decker bus being the equivalent to 75 cars.

Extraordinary.

It just speaks to me that there are some really important frontlines ahead, so I am gonna commit today to take up Roddy's challenge, which was around that scope 3 methodology because actually for us to make progress, we do need to be able to measure, we need to see the wind, we need to see the change, to inspire the next and the next.

I'm going to take up Christina's questions, and it's not just now because I am a cyclist once again. I'm appalled that we are in the lowest 5% in terms of that safe cycling, measure. I'll also take up the 20 mile challenge or the 20 mile per hour challenge. My understanding is in Eastbourne there was consensus around this to look at this, to look to pilot this, to see the difference it can make and I and I confess and I'm embarrassed to confess now only only a little.

When I did my speed awareness course a few years ago, in lieu of picking up three points on my driving licence, I saw a film that demonstrated the impact the collision impact between car and child.was in the film and the difference between 20 miles an hour and 30 miles an hour and 40.

40 was the graveyard slot clearly, 30 was life changing injuries.

20 he lived to tell the tale.

So nothing spoke more to me about what the 20 mile might mean, so I'll I'll take that up too.

I'm also gonna take up cycling on the sea front. Now 10 years ago, I spoke on the Council about about this and back in the day this could divide the room.

Straight down the middle, it was a toxic debate.

We have to find a way through. And finally I'm going to pick up that challenge around the integration of bus and train and and various forms of of transport and and I really experienced that when a few weeks ago I had a conference in in Brighton and I went by train and I came back by bus because of landslips on the rail line, which saw the cancellation of of all the trains.

But again, I think somebody that said this morning in explaining some of the really important measures we need to take, like, duh.

And it seemed to just really communicate the whole. My ask of the organisers, who are probably thinking we are so almost there.

This has been a huge mission to achieve today. My ask for you today is can you bring us all together again around this local plan?

Because this local plan is a seriously important vehicle, it drives policy.

It determines spend.

How can you bring us all together so that contribution, the challenge or the endorsement around that local plan can really shine?

It opens late November.

It closes in February, so we have some time, but I put it to you that document is really defining and one contribution I will make and I'll be seeking your support for this is around another long held ambition and that is a direct service to our hospitals. Because the sorry truth is as we know, uh, one in four families in Eastbourne doesn't have a car, we're not in a world as Christina described, where we're looking at car ownership as the ultimate achievement.

But if you have to travel by bus, currently from Eastbourne, so Hastings, and we do believe, do we not in centres of excellence?

So not all reconfiguration is bad.

It's a 2 1/2 hour journey.

If you travel by car on a good day, 28 minutes is the estimation.

It's so so completely wrong and it's not just patients.

It's those caring for patients because all the statistics show if you don't have visitors, your hospital stay is longer because you don't have that person alongside who's

encouraging you to eat, encouraging you to follow the medical advice, encouraging you to be more mobile.

So it's patients and it's careers, but it's also staff in our hospital trust.

We have over 7000 dedicated staff and in a recent survey around transport for the hospital, what percentage said they travelled between the two sites, 74%.

It's huge and in one year alone, in terms of Miles claimed by our dedicated staff having to travel between the two. Miles, 2,519,848 miles, we're locked up in one year. So I think there's a really important case and I'm very pleased to say that Joel is working with me on Stagecoach.

But I'll be making that submission to the local plan?

And I hope I can have your support on that and all that.

It remains for me to say is have a a, a safe and sustainable journey home.
